1.0 PURPOSE OF THIS REPORT

On April 24, 2009, Conquest Vacations Inc. (the "Company" or "Conquest") made an assignment in bankruptcy naming Ira Smith Trustee & Receiver Inc. ("ISI") as trustee in bankruptcy (the "Trustee"). The Official Receiver appointed ISI as Trustee on April 27, 2009 (the "Date of Bankruptcy"). The appointment of ISI as Trustee was confirmed by the creditors at the First Meeting of Creditors on May 14, 2009. The retainer of Miller Thomson LLP as the Estate Solicitor ("Miller") was confirmed by the Inspectors on the same date.

The purpose of this report is to advise this Honourable Court (and creditors) concerning:

- (i) the TICO Claim (defined below), the disallowance of the TICO Claim delivered by the Trustee and TICO's appeal of the disallowance; and
- (ii) the general administration of this bankruptcy Estate.

2.0 BACKGROUND INFORMATION

The Company was incorporated under the laws of Nova Scotia on May 29, 1998 as Conquest Vacations Company and on December 12, 2006 changed its name to Conquest Vacations Inc. Conquest operated as a travel wholesaler. The Company's head office was located at 85 Brisbane Road, Toronto, ON. The head office operations also occupied space at 99 Brisbane Road, Toronto, ON (the next building to the East of 85 Brisbane Road). There was a sales office located at Unit 311-5400 Airport Road South, Richmond B.C. and a kiosk terminal at Toronto Pearson International Airport.

On April 15, 2009, the Company ceased operations and surrendered the operating licence to the Registrar of the Travel Industry Council of Ontario ("TICO").

The Trustee is in possession of the corporate records. Based on the corporate search of conquest, Mr. Errol Francis and Mr. Simon Bala were the sole Directors of the Company as at the Date of Bankruptcy (the "**Directors**"). Mr. Bala is also the Designated Officer of the Company.

Due to the number of creditors involved and the cost of compliance with section 102 of the *Bankruptcy and Insolvency Act* (Canada) (the "**BIA**"), the Trustee sought and was granted an Order on April 29, 2009, allowing for an alternative method of complying with the requirements of the BIA in providing notice to the creditors with respect to the first meeting of creditors on



May 14, 2009. Attached hereto as **Schedule "A"** is a copy of the issued and entered April 29, 2009 Order.

In accordance with that Order, on May 1, 2009, a cover letter and the Notice of First Meeting was mailed to all known creditors of the Company, and documentation including the Statement of Affairs, a Proof of Claim form and a proxy form were posted on the Trustee's website. The Notice of Bankruptcy and meeting of creditors was published in the May 7, 2009 edition of Report on Business in The Globe and Mail.

3.0 CAUSES OF FINANCIAL DIFFICULTY

The Trustee has been advised that the major causes of the Company's financial difficulties arose as a result of: (i) overcapacity and price wars among the major tour operators and scheduled airlines entering the leisure market and offering highly discounted air fares; (ii) continuing losses; (iii) the rising cost of processing travel related transactions; and (iv) the challenges associated with the flow of credit card payments.

The Trustee's investigations, with the approval of the Estate Inspectors, are ongoing.

4.0 ASSETS

According to the sworn Statement of Affairs, as at the Date of Bankruptcy, the assets of this Estate consist of:

The Trustee has not audited or otherwise verified any of the information contained within the Company's books and records. The estimated value is that of the Designated Officer in his sworn Statement of Affairs. Therefore, the Trustee makes no representations or warranties as to the accuracy or completeness of the financial information set out above.

The offers received by the Trustee for the Furniture and Fixtures located at the various leased locations were lower than the anticipated preferred claims of the landlords (as further indicated below, the Trustee was and continues to be unaware of any party who claims a security interest in these assets). With Inspector approval these assets were abandoned and the premises leases disclaimed on June 30, 2009.



As of December 31, 2009, the Trustee has gross receipts of \$646,237.53, consisting of:

The Bank is also holding an additional \$86,000.00 security deposit pending the settlement of various Letters of Credit issued on behalf of Conquest.

The Trustee continues to pursue other amounts owed to Conquest.

5.0 MAREVA INJUCTION

Prior to the Bankruptcy, on April 17, 2009, CanJet Airlines, a division of I.M.P. Group Limited ("CanJet") obtained a Mareva injunction in Nova Scotia, without notice to the Company, freezing the Company's Canadian assets (the "Mareva Injunction").

Upon appointment, the Trustee issued a Notice of Stay of Proceedings, and provided it to both the Nova Scotia Court and CanJet's legal counsel. Despite communications between the Trustee and Miller with CanJet's counsel in May and June, 2009, CanJet would not initially agree to

vacating the Mareva Injunction. As a consequence and pursuant to a resolution of the Inspectors, Nova Scotia counsel was engaged to seek the dissolution of the Mareva Injunction and ultimately a consent order was granted dissolving and vacating the Mareva Injunction on July 31, 2009. That consent order stated, inter alia, that the Mareva Injunction is dissolved and vacated without costs to any party.

6.0 TICO

TICO is an organization mandated by the Ontario government to administer the Ontario *Travel Industry Act*, 2002 (the "TIA"). As part of its mandate, TICO administers a travel compensation fund. On its website, TICO describes its mission and mandate as follows.

"The Travel Industry Council of Ontario's mission is to promote a fair and informed marketplace where consumers can be confident in their travel purchases. We also support the mission of the Ontario Ministry of Small Business and Consumer Services to maintain a fair, safe and informed marketplace as it relates to Ontario's Travel Industry Act, 2002.

We accomplish this through developing high standards and efficient, effective and relevant regulatory mechanisms in areas such as:

- consumer protection
- consumer education and awareness
- · registration, inspection, supervision and discipline of registrants

investigating and mediating disputes between consumers and registrants"

On April 15, 2009, the Director under the TIA issued an Order freezing the Company's bank accounts with the Bank located in North York, Ontario (the "TICO Freeze Order"). A copy of the TICO Freeze Order is attached as Schedule "B".

The Trustee has advised the Bank that all Conquest funds in accounts subject to the TICO Freeze Order are not to be paid out to any party pending resolution of TICO's secured claim (further described below). A copy of the Trustee's letter to the Bank dated April 27, 2009 is attached as **Schedule "C"**. The Trustee advised the Bank on August 31, 2009 that the Mareva Injunction



had been dissolved, and advised that the three accounts affected by the TICO Claim were to remain frozen. A copy of the letter dated August 31, 2009 is attached as **Schedule "D"**.

The Trustee was in contact with TICO immediately after the bankruptcy filing to discuss matters related to consumer claims and Conquest's cessation of operations on April 15, 2009. The Trustee has maintained a dialogue with TICO.

TICO filed a Proof of Claim, dated May 13, 2009 with the Trustee in which TICO claimed a secured claim against the Estate in the amount of \$1,086,592.84 (the "TICO Claim"). TICO delivered an amended Proof of Claim in the amount of \$2,242,007.57 dated November 22, 2009 in conjunction with this appeal. It is anticipated that a further amended Proof of Claim will be received from TICO once it has completed processing consumer claims in accordance with its statutory mandate. Attached as Schedule "E" is a copy of the TICO Claim. Attached as Schedule "F" is a copy of TICO's Amended Proof of Claim.

The quantum of the TICO Claim, as amended, has not yet been reviewed and it is the Trustee's understanding that TICO's appeal relates to whether TICO is a secured creditor with respect to its claim and not the quantum of the TICO Claim. The Trustee will require the following further information to review and determine the allowable amount of the final TICO Claim amount:

- Names, travel dates, destination, booking reference numbers for each claim paid to individuals.
- Names, travel dates, booking reference numbers for each claim paid to travel service providers.

In order to consider whether the TICO Claim should be allowed or disallowed as a secured claim, the Trustee reviewed the TICO Claim, requested further information from TICO,



reviewed all additional information submitted by TICO, and the Trustee instructed Miller to review the TICO Claim.

On April 22, 2009, an e-mail was sent to Mary-Ann Harrison, CFO and Director of Operations for TICO requesting a copy of any signed agreements between TICO and Conquest and/or the Bank establishing the alleged Trust account. On the same date, Ms. Harrison replied indicating that TICO did not have an agreement with Conquest regarding the trust account, but there was a letter from the Bank acknowledging the account. These e-mails are attached as **Schedule "G"**.

After the appointment of ISI as Trustee, a copy of the Bank's letter dated June 3, 1998 was provided to the Trustee. A copy of this correspondence is attached as **Schedule "H"**.

Following this review, the TICO Claim was addressed at a duly convened meeting of the Inspectors on September 29, 2009. At that meeting, the Inspectors resolved that:

- (i) the TICO Claim be disallowed; and
- (ii) the Trustee was authorized to report to the Court and attend before the Court, with Miller, to oppose any appeal of the Trustee's disallowance of the TICO Claim.

Attached as **Schedule "I"** is an excerpt of the Minutes of the Third Inspectors meeting containing the Inspectors resolution, with respect to the disallowance of the TICO Claim. Attached as **Schedule "J"** is a copy of the disallowance dated October 26, 2009.

With respect to the Trustee's disallowance of the TICO Claim as a secured creditor, the Trustee notes as follows:



6.1 No evidence of a properly perfected secured claim

TICO has not provided evidence of an agreement, security agreement or registration under the Ontario, Nova Scotia or British Columbia Personal Property Security Registration Systems (or otherwise) to demonstrate that it has a perfected security interest. A description of the registrations is set out in Part VII of this Report below.

The TICO Claim does not reference any provisions of the TIA or the TIA Regulations (the "Regulations") which provide the basis for it to advance a secured claim against the Company.

6.2 Regulations provide simply for reimbursement of TICO and not a secured claim for reimbursement

The reimbursement requirement in section 70 of the Regulations does not reference the reimbursement claim as a secured claim or a trust claim payable out of the Trust Account established as required by the regulations.

Section 70 of the Regulations provide as follows:

70. A registrant is required to reimburse the Fund for any claims paid to the registrant's customers under the following circumstances:

1. The registrant is bankrupt or insolvent or has ceased to carry on business.

The registrant purchased travel services on the customer's behalf, extending credit to the
customer, and the customer paid the registrant for the travel services after the supplier of the travel
services had become bankrupt or insolvent or ceased to carry on business. O. Reg. 26/05, s. 70.



6.3 Regulations impress Trust Account with obligations to consumers and travel service providers and not in favour of TICO

Section 27 of the Regulations requires that registrants maintain a trust account for all money received from customers for travel services. However, the trust is not specifically in favour of TICO. In fact, the funds are impressed with the requirement that the funds in the trust account can only be disbursed:

- (a) to make payment to the supplier of the travel services for which the money was received;
- (b) to make a refund to a customer; or
- (c) after the supplier of the travel services has been paid in full, to pay the registrant's commission.

As a result, there is no statutory trust created in favour of TICO to reimburse it for compensation fund payments made by it. Consequently, the Trustee anticipates that it will require directions of the Court and a Court Order prior to distributing the funds held by Conquest in the Bank account noted as "Trust Account" to anyone other than unpaid travel service providers or to consumers for refunds, unless these amounts have been paid in full.

The Trustee respectfully submits that such an Order is consistent with the aims of the BIA, as the funds would be held by the Trustee in the Estate trust bank account for the general benefit of all creditors awaiting distribution in accordance with the provisions of the BIA.



Section 27 of the Regulations provides:

Trust accounts

- 27. (1) A registrant shall maintain a trust account for all money received from customers for travel services. O. Reg. 26/05, s. 27 (1).
- (2) The trust account shall be designated as a Travel Industry Act trust account. O. Reg. 26/05, s. 27 (2).
- (3) A registrant shall hold all money received from customers for travel services in trust and shall deposit all such money into the trust account within two banking days after receiving it. O. Reg. 26/05, s. 27 (3).
- (4) No registrant shall maintain more than one trust account under subsection (1) without the registrar's written consent, obtained in advance. O. Reg. 26/05, s. 27 (4).
- (5) A registrant shall file with the registrar,
- (a) a copy of the trust agreement with the financial institution, within five days after establishing a trust account; and
- (b) a copy of any changes to the trust agreement, within five days after making the changes. O. Reg. 26/05, s. 27 (5).
- (6) No registrant shall disburse or withdraw any money held in a trust account under subsection (1), except,
- (a) to make payment to the supplier of the travel services for which the money was received;
- (b) to make a refund to a customer; or
- (c) after the supplier of the travel services has been paid in full, to pay the registrant's commission.
- O. Reg. 26/05, s. 27 (6).

As indicated above, the Trustee's understanding is that there is no trust agreement, as required under section 27 of the Regulations. On bankruptcy, any deemed trust would lose its priority status unless the requirements of the Act were met and there is no evidence they were met.

Even if there is an argument that Section 27 creates a security interest in favour of TICO, the TIA is provincial legislation and any priority charge created under the TIA or the Regulations loses its priority on bankruptcy. However, it is noted that the language of the TIA does not appear to support a security interest having been created in favour of TICO.

No evidence has been submitted to the Trustee or located by the Trustee to indicate that the requirements for deemed trust priority status has been satisfied.



7.0 SECURED CREDITORS, PROPERTY CLAIMS AND PREFERRED CLAIMS

A search of the Ontario Personal Property Security Registration System as at the Date of Bankruptcy indicates the following parties are claiming a security interest in the assets of the Company:

- 1. Nexcap Finance Corporation
- 2. Financialinx Corporation
- 3. Honda Canada Finance Inc.
- 4. CBCS Capital
- 5. Royal Bank of Canada
- 2148608 Ontario Inc.

A copy of the search of the Ontario Personal Property Security Registration System is attached as Schedule "K".

As indicated above, the Company is a Nova Scotia company, its head office was in Ontario and it also maintained a sales office in British Columbia. As a result of the multi-jurisdictional nature of the Debtor's business, searches of the Personal Property registration systems in Nova Scotia and British Columbia have also been undertaken. As of the Date of the Bankruptcy, there were no registrations in either the Nova Scotia or the British Columbia Personal Property Security Registration Systems. A copy of those search results are attached as **Schedule "L"**.

The Trustee reports as follows at this time concerning the security registrations.

7.1 Nexcap Finance Corporation

No claim has been filed by Nexcap to date.



7.2 Financialinx Corporation ("Financialinx")

The leased vehicle covered by the Financialinx security, was delivered by the Designated Director to the Trustee. Upon determining that there was no equity associated with the lease of the vehicle it was released to a representative of Financialinx. No claim has been filed by Financialinx to date.

7.3 Honda Canada Finance Inc. ("Honda")

The Trustee has been advised that Honda had taken possession of vehicles covered under its security prior to the Date of Bankruptcy. No claim has been filed by Honda to date.

7.4 CBCS Capital

The leased copier was returned by the Trustee to representatives of CBCS. CBCS filed an unsecured claim in the Estate for the balance of lease payments owed.

7.5 The Bank

The Bank registered security in respect of a term deposit pledged by the Company to it in the amount of \$503,267. This pledge was to support outstanding letters of credit totalling \$321,000 at that time. On May 6, 2009, RBC filed a secured Proof of Claim in the amount of \$127,427.27. As of December 31, 2009 there remained \$76,000 in outstanding letters of credit. As agreed between the Bank and the Trustee, \$86,000 is being held pending settlement of the outstanding letters of credit and the Bank's legal costs.



7.6 2148608 Ontario Inc. ("214")

We have been advised by Mr. Simon Bala, the beneficial owner of 214 and the Designated Officer, that as of the Date of Bankruptcy, no amounts covered by the registered security are owed to 214.

The Trustee instructed Miller to review the general security agreement (the "General Security Agreement") dated as of March 19, 2009, granted by the Debtor in favour of 214, and the transactions noted in Conquest's books and records as "Shareholder Loan Repayments" to 214.

Following receipt of Miller's opinion, the Inspectors resolved that:

- (i) 214 be notified that the General Security Agreement, and the associated registration, is a charge granted during the period that is three months before the date of the making of the Assignment in Bankruptcy and as such is void as against the Trustee;
- (ii) as the General Security Agreement was granted as of March 19, 2009, the charge will be presumed to be a preference in the absence of evidence to the contrary, and to provide 214 with an opportunity to submit evidence to the contrary; and
- (iii) demand repayment of the \$750,000 paid by Conquest to 214 in March and April, 2009.

In response to the letter from Miller to counsel for 214, 214 has informed the Trustee that the General Security Agreement related to a form of revolving account put in place by 214 to finance Conquest's operations, and 214 takes the position that its security is valid and there are no funds owing by 214 to Conquest. The Trustee will seek instructions and directions from the Inspectors



with respect to this matter. Attached as **Schedule "M"** is a copy of the letter dated November 25, 2009 from Miller to counsel for 214 and attached as **Schedule "N"** is a copy of the letter from counsel for 214 to Miller dated December 15, 2009

7.7 Other Leases

Other assets subject to valid lease agreements have been returned to the appropriate parties.

7.8 Deemed Trusts

A payroll audit was conducted by Canada Revenue Agency. They have determined that \$29,639.61 is owed by Conquest. A portion of this amount, \$19,603.64, is a deemed trust claim on account of CPP/EI which should have been withheld from employees in their final payroll and remitted to Canada Revenue Agency, which has priority over all secured and unsecured creditors. The Trustee is awaiting the assessment notice from Canada Revenue Agency.

7.9 Landlord

As agreed by between the Trustee and the landlords of the Toronto head office premises, there will be no preferred claims by the landlords as the Trustee abandoned all furniture and fixtures located at leased locations to them and has disclaimed the leases. To date, the landlords of the various leased locations have not filed claims in the Estate of Conquest.

7.10 Wage Earner Protection Program Act ("WEPPA")

The Trustee's review of the books and records of the Company indicated that employee wages and vacation pay were paid up to the Date of Bankruptcy and an amount equal to one month's wages was paid to each employee on account of severance and termination.



As required by the WEPPA, the Trustee registered with Service Canada and provided all required information. As of December 28, 2009, \$204,967.73 had been paid to former employees pursuant to the WEPPA. The payments made under WEPPA relate to severance and termination and the Trustee has been advised by Miller, that these do not constitute a priority claim pursuant to section 81.3 of the BIA.

The Ministry of Labour ("MOL") conducted an audit and determined that there are severance and termination amounts owing in excess of what was paid by WEPPA to employees based on their length of employment with the Company. These claims have been filed as unsecured claims in the Estate by the MOL on behalf of these employees.

7.11 E-Commerce Risk Management

E-Commerce Risk Management Limited ("E-Commerce") is a company carrying on business in London, England. E-Commerce was the credit card processing intermediary pursuant to an Agreement between Conquest and E-Commerce dated September, 2007 (the "Agreement").

We were advised by the designated officer that there were substantial unpaid amounts owing by E-Commerce to Conquest with respect to unremitted credit card payments from Conquest customers. Upon appointment, the Trustee made demand for payment and requested a full accounting of funds held and anticipated chargebacks. A copy of the Trustee's letter to E-Commerce dated April 28, 2009 is attached as **Schedule "O"**.

In May, 2009, E-Commerce submitted a proof of claim related to potential chargeback claims that were in excess of the unpaid amounts. The Agreement had a six-month chargeback period, and, as the chargeback period set out in the Agreement has expired, the Estate Solicitor



requested on November 28, 2009, a detailed accounting of (i) E-Commerce's claim for charge-backs under the Agreement, (ii) the funds held by E-Commerce belonging to Conquest, and (iii) an updated Proof of Claim. To date, E-Commerce has not responded to the Trustee.

7.12 Summary

As set out above, TICO has appealed the disallowance of its secured claim. The determination by the Court with respect to TICO's appeal of the disallowance will determine whether or not the TICO Claim is that of a secured creditor which will rank in priority to the unsecured creditors.

Accordingly and subject to the Court's determination of TICO's appeal, it is the Trustee's current understanding that the only claims which rank in priority to the claims of the ordinary unsecured creditors are:

- the deemed trust portion of the claim of Canada Revenue Agency for unremitted source deductions (described above);
- 2. the secured claim of RBC (described above); and
- 3. the taxed fees and costs of the Trustee and the Estate Solicitor in accordance with section 136(1)(b) of the BIA.

The above is subject to the ongoing review of claims received by the Trustee which have not yet been subject to review and additional claims that may be received by the Trustee.



8.0 CREDITORS' CLAIMS

The known creditor claims as at the Date of Bankruptcy, according to the sworn Statement of Affairs, compared to the Proofs of Claim received by the Trustee as at 5:00 p.m. on December 31, 2009, are summarized as follows:

9.0 ANTICIPATED REALIZATION AND PROJECTED DISTRIBUTION

The Trustee anticipates that there will be distributions to Canada Revenue Agency on account of its anticipated deemed trust claim and to ordinary unsecured creditors. The amount of the distribution to unsecured creditors is dependent upon the quantum of any realization arising from: (i) the settlement of the funds held by the RBC pursuant to the TICO Claim; and (ii) recovery of other amounts, if any.



Accordingly, it is premature at this time, and will no doubt take a considerable amount of time before the Trustee is in any position, to forecast what amount of dividend, will be payable to the ordinary unsecured creditors from this bankruptcy administration.

The meeting was called to order and a quorum was declared with four of the five inspectors in attendance. It was noted that Brian Pereira could not remain on the line for the entire meeting due to a personal conflict. Marti Aragones could not attend but has requested that a copy of the Meeting Minutes be sent to him.

Resolution:

On motion made by Mr. Gill, seconded by Ms. Yurman, the Inspectors resolved that:

- TICO's secured claim is disallowed with full reasons (from the Miller Thompson memo) without prejudice to their right to file a definitive final claim as an ordinary unsecured creditor (once fully quantified by the actual amount of money paid out by TICO).
- If there is an appeal then the trustee is to attend in court with legal counsel for the purpose of assisting the court in its decision.

The motion was opposed by Mr. Frank Demarinis but carried by the majority.

Frank offered the following comment on the rationale for his opposition:

• I do take a different view because in maintaining the trust account in the industry those are clients' funds and at the end of the day the reason for the trust account is to maintain that – to maintain that as a credibility and essentially what is happening here is we are disallowing the consumers to have access to their own money.

There was some general discussion regarding TICO's role, the purpose of the trust fund, TICO's anticipated reaction and the general level of claims by the different groups in the Conquest Estate.

2. Review of the Books and Records

Elaine Kilmer-Choi reviewed the findings of the Trustee's review of the books and records of Conquest. The detailed report, along with supporting spreadsheets had been previously provided to the inspectors.

The following is a summary:

From the Canadian Trust account the following transactions to 2148608 Ontario Inc. were noted as Shareholder Loan repayments:

One was for the period up to the middle of June, which was \$13,930. There was a next bill dated July 22^{nd} which covers the period up until July 9, 2009 totalling \$21,009.71 and the final one that covered time up until August 18^{th} for \$6,700.95. We are looking for the inspectors to approve those three bills.

On motion made by Mr. Demarinis and seconded by Mr. Gill, the Inspectors resolved that:

The three presented invoices for Miller Thomson are approved for payment. Motion was carried unanimously.

Interim Draw Approval

The Trustee's billing for June 1 to September 15, 2009 was provided to the inspectors for review. The total amount including expenses and GST was \$132,103.56. The Trustee requested an interim draw on account of the Trustee's fee in the amount \$75,000 on account of fee plus GST, and disbursements of \$170.41 plus GST.

Resolution:

On motion made by Mr. Gill, seconded by Mr. Demarinis and carried unanimously, the Inspectors resolved that the interim draw for the Trustee on account of its fee in the amount of \$75,000 plus disbursements and GST.

NOTICE OF DISALLOWANCE OF CLAIM, RIGHT TO PRIORITY OR SECURITY (Subsection 135(3))

IN THE MATTER OF THE BANKRUPTCY OF CONQUEST VACATIONS INC. A COMPANY INCORPORATED PURSUANT TO THE LAWS OF NOVA SCOTIA AND CARRYING ON BUSINESS IN THE CITY OF TORONTO IN THE PROVINCE OF ONTARIO

TAKE NOTICE THAT, as trustee of the above estate, we have disallowed your secured claim against the estate in whole, in the amount of \$1,086,592.84, pursuant to subsection 135(2) of the *Bankruptcy and Insolvency Act* (Canada) (the "Act"), for the following reasons:

No evidence of a properly perfected secured claim.

Travel Industry Council of Ontario ("TICO") has not provided evidence of a security agreement or registration under the *Personal Property Security Act* (or otherwise) to demonstrate that it has a perfected security interest.

We assume that the secured claim is based upon the provisions of the *Travel Industry Act*, 2002 S.O. 2002 (the "*Travel Industry Act*") and the Regulations, but no provisions are referenced in the TICO Proof of Claim.

Conquest Vacations Inc. was a registrant under the Travel Industry Act.

2. Regulations provide simply for reimbursement of TICO and not a secured claim for reimbursement.

The reimbursement requirement in section 70 of the Regulations does not reference the reimbursement claim as a secured claim or a trust claim payable out of the Trust Account established as required by the regulations.

Section 70 of the Regulations provide:

- 70. A registrant is required to reimburse the Fund for any claims paid to the registrant's customers under the following circumstances:
 - 1. The registrant is bankrupt or insolvent or has ceased to carry on business.
 - 2. The registrant purchased travel services on the customer's behalf, extending credit to the customer, and the customer paid the registrant for the travel services after the supplier of the travel services had become bankrupt or insolvent or ceased to carry on business. O. Reg. 26/05, s. 70.

3. Regulations impress Trust Account with obligations to consumers and travel service providers and not in favour of TICO.

Section 27 of the Regulations require that registrants maintain trust account for all money received from customers for travel services. However, the trust is not specifically in favour of TICO. In fact, the funds are impressed with the requirement that the funds in the trust account can only be disbursed:

- (a) to make payment to the supplier of the travel services for which the money was received;
- (b) to make a refund to a customer; or
- (c) after the supplier of the travel services has been paid in full, to pay the registrant's commission.

As a result, there is no statutory trust created in favour of TICO to reimburse it for compensation fund payments made by it. The funds are in place to either (i) refund customers or (ii) make payments to suppliers of travel services, and once all such amounts are paid in full then Conquest can be paid its commissions on the travel services sold by it.

Section 27 of the Regulations provides.

Trust accounts

- 27. (1) A registrant shall maintain a trust account for all money received from customers for travel services. O. Reg. 26/05, s. 27 (1).
- (2) The trust account shall be designated as a Travel Industry Act trust account. O. Reg. 26/05, s. 27 (2).
- (3) A registrant shall hold all money received from customers for travel services in trust and shall deposit all such money into the trust account within two banking days after receiving it. O. Reg. 26/05, s. 27 (3).
- (4) No registrant shall maintain more than one trust account under subsection (1) without the registrar's written consent, obtained in advance. O. Reg. 26/05, s. 27 (4).
- (5) A registrant shall file with the registrar,
- (a) a copy of the trust agreement with the financial institution, within five days after establishing a trust account; and
- (b) a copy of any changes to the trust agreement, within five days after making the changes. O. Reg. 26/05, s. 27 (5).
- (6) No registrant shall disburse or withdraw any money held in a trust account under subsection (1), except,



- (a) to make payment to the supplier of the travel services for which the money was received;
- (b) to make a refund to a customer; or
- (c) after the supplier of the travel services has been paid in full, to pay the registrant's commission. O. Reg. 26/05, s. 27 (6).

4. On bankruptcy, any deemed trust loses its priority status unless Act requirements were met and there is no evidence that these were met.

Even if section 27 created a security interest in favour of TICO, the *Travel Industry Act* is provincial legislation and we maintain that any priority charge created under the *Travel Industry Act* or Regulations loses its priority on bankruptcy. This position is analogous to the loss of deemed trust priority which occurs with respect to PST on a bankruptcy and loss of priority for other Crown or provincial claims where there was prior registration of such a secured claim.

And further take notice that the disallowance of the secured claim of TICO is without prejudice to the right of TICO to file a definitive final claim as an ordinary unsecured creditor once the payments required to be made by TICO with respect to the bankruptcy of Conquest are fully quantified.

And further take notice that if you are dissatisfied with our decision in disallowing your claim in whole or in part, you may appeal to the court within the 30-day period after the day on which this notice is served, or within such other period as the court may, on application made within the same 30-day period, allow.

As you are aware, we are counsel for the Trustee in Bankruptcy of Conquest (the "Trustee"). We understand that you act for 214 and Simon Bala.

We write with respect to the following matters:

- (i) the general security agreement (the "General Security Agreement") dated as of March 19, 2009, granted by the Debtor in favour of 2148608 Ontario Inc. ("214");
- (ii) the transactions noted in Conquest's books and records as "Shareholder Loan Repayments" to 214; and
- (iii) to demand repayment of payments made to 214 in the immediate two months preceding the bankruptcy.
- (i) General Security Agreement

As a result of the provisions of the *Bankruptcy and Insolvency Act* (Canada) (the "BIA"), the security of 214 in the personal property of the Debtor described in the General Security Agreement is void as against the Trustee in Bankruptcy and Shareholder Loan Advances by 214 are unsecured claims as against the Conquest estate. The reasons are as follows.

1. The BIA provides that a charge on property made, a payment made or an obligation incurred, which has the effect of giving a creditor a preference over another creditor, in the period which is three months before the date of the initial bankruptcy event for

arm's length creditors, and which is twelve months before the date of the initial bankruptcy event for non-arm's length creditors, is void as against the trustee in bankruptcy.

- 2. 214 is a creditor not dealing at arm's length with Conquest.
 - (a) The directors and officers of Conquest were Errol Francis and Simon Bala at the time in question.
 - (b) The sole director and officer of 214 is Shiva Simon Bala.
 - (c) The Trustee has been informed that Simon Bala is the beneficial owner of all of the shares of 214.
- Conquest made an assignment in bankruptcy on April 27, 2009.
- 4. The General Security Agreement, and the associated registration, is a charge granted during the period that is three months before the date of the making of the assignment in bankruptcy and as such is void as against the trustee in bankruptcy.¹
- 5. As the General Security Agreement was granted as of March 19, 2009, the charge will be presumed to be a preference in the absence of evidence to the contrary. We are not aware of evidence to the contrary being submitted by 214. If 214 wishes to submit evidence to the contrary, please do so as soon as possible and, in any event, no later than December 10, 2009.
- (ii) The Shareholder Loan Repayments made to 214 in the twelve months preceding the Conquest bankruptcy are void as against the trustee in bankruptcy.

As a result of the provisions of the BIA, the Shareholder Loan Repayments made to 214 in the twelve months preceding the Conquest bankruptcy are void as against the trustee in bankruptcy. The reasons are as follows:

- 1. As set out above, 214 is a creditor not dealing at arm's length with Conquest and Conquest made an assignment in bankruptcy on April 27, 2009.
- Further as set out above, payments made or obligations incurred in the period which is three months before the date of the initial bankruptcy event for arm's length creditors, and which is twelve months before the date of the initial bankruptcy event for non-arm's length creditors, is void as against the trustee in bankruptcy.

It is noted that, as a non arm's length transaction, the review period is 12 months from the initial bankruptcy event. However, in this instance, the three month period set out in section 95(1)(a) of the BIA, as amended and declared in force on September 18, 2009, is sufficient to result in this charge being void as against the trustee in bankruptcy.

- 3. The payments made by Conquest to 214 had the effect of giving 214 a preference over other creditors of Conquest. As a consequence, the payments made by Conquest to 214 in the year before April 27, 2009 are void as against the trustee in bankruptcy.
- 4. In particular, the following payments from Conquest to 214 are void as against the trustee in bankruptcy.

As these payments were made in the 2 months preceding the bankruptcy and the security related to the underlying loan was granted as of March 19, 2009, the payments are void as against the Trustee in the absence of evidence to the contrary. We are not aware of evidence to the contrary being submitted by 214. If 214 wishes to submit evidence to the contrary, please do so as soon as possible and, in any event, no later than December 10, 2009.

(iii) Demand for Repayment to Estate

As a consequence of the foregoing, we are instructed to hereby demand repayment of the \$750,000 paid by Conquest to 214.

We are counsel for 2148608 Ontario Inc. ("214") and write further to your correspondence dated November 25, 2009.

In or about March 2009, and due to the global economic credit crunch and credit card processing delays, Conquest's working capital and cash flow situation were severely impacted. economic credit crunch affected the ability of credit card intermediaries to process credit card payments promptly and remit such funds to Conquest. Accordingly, the flow of funds to Conquest was often delayed to the detriment of Conquest's business affairs. Delayed payments resulted in less available working capital and, accordingly, affected Conquest's ability to make payments to employees, pay airlines and other suppliers promptly.

Given these concerns, it was impossible to carry on Conquest's operations without additional funding to off-set the credit processing delays. The shareholders, in response to the fact that other forms of financing were not available, elected to create a form of revolving account in order to ensure that Conquest's obligations and responsibilities could be met on time. The shareholders accordingly advanced the funds described in enumerated paragraph four of page three of your letter regarding 214 to Conquest in order that business operations could continue, in return for Conquest's agreement to provide security for all funds advanced.

These shareholder advances and repayments were made through 214 to Conquest as follows:



Advance on March 3, 2009 to account no. 112-3	500,000
Loan repaid, March 18, 2009	-300,000
General Security Agreement	March 19, 2009
Loan repaid, April 2, 2009	-200,000
Advance on April 14, 2009 to account no. 112-3	250,000
Loan repaid, April 14, 2009	-150,000
Loan repaid, April 15, 2009	-100,000
Advance on April 16 2009 to account no. 102-903-2	40,000
Balance owing to 214	40,000

Essentially, on any day when Conquest was unable to meet it immediate daily cash requirements for, *inter alia*, payroll and/or airline departures, 214 advanced the necessary funds to fund any Conquest obligations on the understanding that same would be repaid out of Conquest's first available funds.

The foregoing is consistent with the statements made to the Trustee and reflected in the Trustee's original Report regarding shareholder loans.

The amount of \$250,000 was advanced on April 14, 2009 as there was not sufficient funds in Conquest to make the required airline payments for that day. The \$250,000 was advanced by Lawton o.b.o 214.

The shareholders realized that there would not be enough funds coming in for the flight payments required on April 15, 2009 and accordingly elected to cease operations effective that day. The Travel Industry Council of Ontario froze Conquest's trust accounts on the same day, leaving only the operating account still in operation.

On the same day the announcement was made that Conquest was ceasing operations, some funds were received from the credit processing company and, accordingly, the amount of \$250,000 was repaid to 214. At that time, 214 was a secured creditor of Conquest.

On April 16, 2009, \$40,000 was advanced by 214 to Conquest's operating account to cover employee compensation. These funds, however, were frozen as a result of the injunction obtained by Canjet Airlines in Nova Scotia.

As is evident from the foregoing, the advances made by 214 were designed solely to assist Conquest in carrying on business and to ensure that Conquest's suppliers and employees were



paid, and that its customers received the services paid for. We accordingly take the position that there are no funds owing by 214 to Conquest.
